


Task WP8.1.3: Operationalise the vocabulary builder (NERC-BODC)



Background

• P01 concept labels are created from a concatenation of concept labels from other vocabularies following an underlying semantic model.





P01 concepts available as semantic models


- Chemical entity parameter codes
- Biological entity parameter codes
- Physical entity and other parameter codes



Vocab Builder


- Search vocabularies based on constituent elements
- If the searched combination does not exist, submit a new combination for creation

 - Adopt best practices as determined by RDA Vocabularies Services Interest Group
- Document the model based on ADMS and the RDA VSIG suggestion
- Use <u>http://purl.org/linked-data/registry</u> ontology
- Circulate to partners and VSSIG group

SeaDataCloud WP8.1.2 Developing new vocabularies progress I


- Sensor Web Enablement (SWE) Marine Profile Group
